CONSIDERANDO:

Que se hace necesario autorizar al Departamento Ejecutivo Municipal a gestionar y contratar en forma directa con el Gobierno de Mendoza, un préstamo para ser destinado al reequipamiento del parque automotor municipal.

ARTÍCULO 1): Autorícese al Departamento Ejecutivo Municipal a gestionar y contratar en forma directa con el Gobierno de Mendoza – Argentina, en los términos del Artículo 29° inc. b) Apartado 2 de la Ley N° 3799, un préstamo por un monto total de PESOS: UN MILLÓN CIENTO MIL CON 00/100 (\$1.100.000,00), con un interés financiero de hasta el doce por ciento (12%) fijo anual, para ser destinado al reequipamiento del parque automotor municipal, tratándose de una retroexcavadora, una minicargadora, dos camiones y una barredora.

ARTÍCULO 2): Autorícese al Departamento Ejecutivo Municipal a afectar los ingresos municipales provenientes de la coparticipación de impuestos nacionales y provinciales, como garantía del crédito, hasta el monto correspondiente a la amortización de la deuda contraída por el Municipio, la que será amortizada en un plazo no mayor a 5 años.
